APPOINT TIF CONSULTANT & TIF LEGAL

Mayor McArty presented to the board an ordinance allowing Jacob & Klein, Ltd. authorization to enter into a professional services agreement for the administration of the Oakwood Interstate Tax Increment District. The mayor explained this is required to be approved through ordinance because it is being paid through TIF funds. B. Parr asked if any other municipalities have utilized this Ltd. Mayor McArty responded that they come highly from several municipalities. L. Light asked about the part of the agreement that they would not represent the village legally and wondered why we would pay without any representation. C. Fritz stated it would be nice to have an attorney present who can research and explain questions the board has.

- R. Wright asked if quarterly meetings could be focused on TIF requests, which would allow for a study session. Mayor McArty reminded the board that all TIF projects are brought to the board and voted on by the board. She also explained tabling this ordnance would put a hold on the current TIF requests that have been received.
- F. Stroh stated if the board had people not agreeing, then maybe this needs to be tabled and discussed at a study session and to appoint someone to get more information to make an informed vote.

Ferrell Stroh motioned to table this ordinance so it could be discussed at a study session.

WATCHFIRE SIGN
