## BUDGET

The budget was presented to the board previously via email. Mayor McArty called questions on the budget to the floor. Robert Wright mentioned he was confused as there was no note of debits or credits on the presented budget, stating that one was just to assume what things were. There was discussion on what each line pays, what the departments are authorized to purchase on their own within their budget, and what the mayor was authorized to spend. Lindsay Light mentioned we might want to review that policy. Cathi Fritz stated she had several questions and the budget was hard to understand. Robert Wright stated this was a confusing presentation of a budget, and a few on the board agreed it was hard to approve this budget as presented. Lindsay Light mentioned the department heads coming before the board, answering questions, & providing a narrative of their budgets so the members can understand what they're approving. She stated she understands they met with the mayor, but it's a lot to expect the mayor to answer for all departments when it comes to the details of each line. Discussion ensued on the accounting software and the possibility it was outdated or there needs to be more training on the current software. Lindsay questioned why we don't have more control over our own accounting. Specific questions were brought to the table, so it was discussed to have a special budget meeting prior to Monday's meeting for the department heads to answer any questions. Mayor McArty will also send out the budget narratives for each department. In discussion of various department budgets, Cathi Fritz suggested the possibility of employing more than one school resource officer. Discussion ensued on school safety in relation to what we could do to support the schools' security. Bob Parr asked about the purchase of a barrier in the wake of the shooting in Texas.

## INVESTING PRESENTATION

Mayor McArty tabled this item for now as the presentations were not ready for this meeting.

# PARK IMPROVEMENTS

Mayor McArty presented the project proposal from Duzan Architecture Design & Inc. in the amount of \$24,200.00 for approval.
